# How to complete a new application for registration in the Brands Online Portal

#### **Prerequisite**

#### 1. Login to the Brands Online Portal

When logging into the Brands Online Portal, you will need to have a myGovID set up. If you do not have a myGovID already set up, instructions on **setting up your myGovID** are available online.

Once you have logged into the portal using your myGovID, you will be taken to the "**New Submissions**" page.

You must complete all **mandatory fields** in order to submit the online registration.

It also allows us to send you information on correctly identifying and moving the type of livestock you will specifically have.

**Note:** If there is a category of livestock that you do not have, please leave it blank<u>, do not</u> <u>enter the number 0</u>. These numbers can be estimates, they do not have to be exact, but the more accurate the better.
