FOCUS DECLARED PESTS

With community and key stakeholder input, Blackwood Biosecurity Inc. has been actively involved with landholders (regardless of property size) in an across-Shire approach, to manage the priority declared pests:



Narrowleaf cotton bush



Cape tulip



Rabbits



Paterson's curse



Bridal creeper



Fox



Blackberry



Cleavers



Feral pig

These pests are all expensive and difficult to control and can have devastating impacts on agriculture, the natural environment and human amenity, health and safety.

While landholders ultimately remain responsible for declared pests on their properties, they can also need to be better resourced and supported, with access to best practice equipment and advice.

Landholders have benefited from coordinated control strategies, up to date research and development, participation in control trials, free training and workshops, subsidised licenses, on-ground resources, returnable deposit hire of weed and animal control equipment, alerts for new biosecurity threats and where appropriate assistance from Licensed Vertebrate Pest Operators for removal of rogue feral animals.

Blackwood Biosecurity Inc. is a not for profit incorporated association guided by a general and executive committee comprised of volunteer community members representing their shires of Bridgetown-Greenbushes, Boyup Brook, West Arthur and Donnybrook-Balingup South.





DECLARED PEST RATE COLLECTION

The Commissioner of State Revenue through the Office of State Revenue (OSR) is responsible for issuing and collecting Declared Pest Rates. This is done in September/October each year.

SHIRE COUNCILS ARE NOT INVOLVED IN DECLARED PEST RATES.

Postponement for pensioners

Eligible pensioners can apply to the OSR to have their rate payments postponed, provided they meet the requirements under section 136 of the Biosecurity and Agriculture Management Act 2007.



Bronwyn Mitchell called on Blackwood Biosecurity for help after having foxes work their way into her very sturdy enclosures killing 19 of her cherished rare birds. Vertebrate Field Officer, Clinton Best, whistled up and dispatched five foxes for her the next night, and has gone on to remove many more.

Bronwyne said: "I was a bit cross when I received my pest rate....but I'm not cross anymore. More people should be using this service".



SINCE OUR LAST A.G.M.

Blackwood Biosecurity Inc was one of 12 Western Australian regional groups to have a declared pest rate determined by the Minister for Agriculture and Food on the 30 th July 2018.

In Blackwood Biosecurity's Operational Area, the Minister declared a rate in the three Shires of Bridgetown-Greenbushes, Donnybrook-Balingup South and West Arthur of \$40 on land within a town-site(residential) or \$50 on freehold land rural. The Western Australian Government matched those rates, up front, to strengthen local efforts to control feral animal and plant pests.

In 2019 the Minister has again declared a pest rate of \$40 on land within a town-site(residential) or \$50 on Freehold land rural, this time in the four Shires of Boyup Brook, West Arthur, Donnybrook-Balingup South and Bridgetown-Greenbushes.



FERAL ANIMALS



- Removed 340 rogue foxes from townsites and rural properties where requested.
- Set traps for inexperienced landholders and euthanised trapped animals.
- Provided Monitoring cameras for landholder use.
- Shooter and fox control workshops.



- Released K5 calicivirus, and in recent weeks distributed dead rabbits infected with new virus throughout operational area.
- On-site appraisals for rabbit control options.
- Hand held spotlights provided to landholders for monitoring.
- Smoke machine hire for landholders to identify warren openings.
- Provided rabbit traps for landholders and euthanize trapped animals where requested.
- Shot 340 rabbits and continue to manually remove virus resistant populations from burrows.



- Removed more than 180 feral pigs (mostly in West Arthur & Boyup Brook) at landholder request.
- Provided monitoring cameras, pre-feed.
- Established permanent feral pig traps with landholders.
- Negotiated MOU with DBCA to pursue and dispatch feral pigs on the public estate, when impacting on neighbouring farms.
- Stakeholder W.A. Feral Pig Strategy Review.



- Removed 19 feral cats.
- Traps available for landholders use.

- Offered Blackberry Control Trials using very low dose chemical. Trials were well subscribed in Bridgetown-Greenbushes and Donnybrook-Balingup South.



Community groups, or landholders, can hire weed leavers to assist in weed control activities. They are great for pulling out mature cotton bush plants.




2019/2020 DRAFT BUDGET

This is a working document as planned actions will be governed by landholder uptake and percentage of rate monies collected each year determines final amount available to deliver activities.

The draft 2020 21 Operational Plan has an estimated budget of \$373,830 plus a contingency for unpaid/postponed rates of \$111,591.

PROPOSED CHANGE OF FINANCIAL ACCOUNTING PERIOD

Notice of motion for AGM Special resolution to alter accounting period.

Currently Blackwood Biosecurity Inc. operates on a financial accounting period, that is, July 1st to June 30th. Notice of a special resolution has been given to propose that Blackwood Biosecurity Inc. instead operates on a calendar accounting period. That is, January 1st to December 31st. The special resolution will allow Blackwood Biosecurity Inc. to better align its budgeting processes and operations with DPIRD'S funding schedule and reporting requirements.



Travel in the future

Kilometres travelled by our Biosecurity Staff in the last twelve months have exceeded our expectations. In the financial year 30 th June 2018 to 1 st July 2019 staff travelled 16,000 kilometres to visit landholders' properties and have clocked up a further 7,546 kilometres since then.

We initially balked at the cost of either purchasing or leasing a work vehicle and all staff generously offered to use their own vehicles, but now realise that kilometres are such that they are wearing their own vehicles out.

So, we will be re-examining the vehicle purchase or lease options (including external funding) again in the New Year.
